## Background and Aims of Meeting

The Higher Education Research and Advocacy Network in Africa (HERANA) was established in 2007 and is coordinated by the Centre for Higher Education Transformation in Cape Town, South Africa. Key partners include the University of the Western Cape (South Africa), Makerere University (Uganda) and the University of Oslo (Norway). The aims of the project, which covers 8 African countries, are to explore the relationship between economic policy and institutions, on the one hand, and the institutionalization of development, on the other. The research and advocacy components of HERANA are funded by the Carnegie Corporation of New York, the Ford Foundation, the Rockefeller Foundation and the Kresge Foundation. Norad's Programme for Master Studies (funded by Norad).

The main aims of the meeting will be to:

- Do a brief overview of the project and its analytical framework
- Report on the main findings – focusing on Makerere and Dar-es-Salaam
- Comment on some implications for funders/development agencies
- Reflect on the experiences of five US Foundations in 'partnership' funding in Africa
